INFORMATION AND INSTRUCTIONS

Articles of Incorporation—Non-Profit Corporations (Excluding Ecclosiastical Corporations)

- 1. Article II should state, In general terms, the specific purpose or object for which the corporation is organized.
- 2. Article IV—A post office box is not permitted to be designated as the address of the registered office in part 1 of Article IV. The mailing address In part 2 of Article IV may differ from the address of the registered office only if a post office box address in the same city as the registered office is designated as the mailing address.
- Article V-At least three incorporators are required. Article VI-At least three directors (or trustees)
 ore required. The addresses should include a street number and name (or other designation), in
 addition to the name of the city and state.
- A. The duration of the corporation should be stated in the Articles only if the duration is not perpetual.
- The Articles must be signed in ink by each Incorporator. The names of the incorporators as set out In Article V should correspond with the signatures.
- An effective date, not later than 90 days subsequent to the date of filing, may be stated in the Articles of Incorporation.
- One original copy of the Articles is required. A true copy will be prepared by the Corporation and Securities Bureau and returned to the person submitting the Articles for filling.
- FEES: \$10.00 filing plus \$10.00 franchise; total \$20.00. Checks' or money orders should be made payable to the State of Michigan.
